My dear Chairman,

Re. CABAL

I plan to be in the United States in connection with the regular biennial inspection of the security arrangements for the protection of NATO information and would like to propose that I carry out an inspection of the Standing Group CABAL Registry on the afternoon of October 2nd. I should during my United States visit also inspect the CABAL arrangements at SACLANT Headquarters and would like to suggest that I do so on September 25th around 10 a.m. If you could make these arrangements for me I should be most grateful. I shall telephone you on September 21st at which time I would hope you will be able to inform me regarding the person I should contact at SACLANT Headquarters and in order to seek your agreement for a visit with you on October 2nd to discuss any matters of mutual interest having in mind particularly EUROCONTROL and the revision of CM(55)15(Final).
