1. AFTER A BRIEF INFORMAL EXCHANGE OF VIEWS ON REVIEW OF
INFRASTRUCTURE (REF.), THE GROUP AGREED THAT WORK COULD NOW
PROCEED NORMALLY ON PROJECTS WHICH WERE NOT CONTAINED IN THE
REVIEW AND THAT SIMULTANEOUSLY NO FURTHER ACTION WOULD BE TAKEN
TO SIGN CONTRACTS IN RESPECT OF ANY PROJECTS LISTED IN REVIEW
THIS WAS SUBJECT TO CONFIRMATION BY GREECE, GERMANY, NETHERLANDS,
TURKEY AND U.K. U.S. REP. STATED THAT HIS AUTHORITIES WOULD BE
UNLIKELY TO CONTRIBUTE TO ANY PROJECT INCLUDED IN REVIEW FOR

CATEGORY PROPOSED FOR DEFERMENT OR DELETION, AND THOSE ELIGIBLE

UNDER REVIEW.

3. GROUP AGREED TO CONTINUE DISCUSSION AT NEXT MEETING (NOW

SCHEDULED FOR TUESDAY, 7 MAR. 67) ON FUTURE COURSE OF ACTION TO
BE ADOPTED ONCE MC HAS COMPLETED ITS STUDY OF REVIEW. IN
PARTICULAR, GROUP WOULD ADDRESS PROBLEM OF DELETING ALL PROJECTS
MENTIONED IN REVIEW OR SUSPENDING ALL EXCEPT PROJECTS IN GROUP 1
OF ANNEX B OF REF. WHICH COULD BE ALLOWED TO PROCEED BY ORDER OF
PRIORITY. GROUP ALSO AGREED TO CONTINUE DISCUSSION OF PRIORITY

OF DIFFERENT CATEGORIES BASED UPON ADVICE OF NATO MILITARY
AUTHORITIES.
