MEMORANDUM FOR THE MILITARY REPRESENTATIVES

SUBJECT: Requirements for the Standing Group Liaison Office  
at New NATO Headquarters

Reference: S.G. 112/8

1. At the 41st Meeting of the Military Representatives Committee on 13 March 1952, no action on S.G. 112/8 was taken since the paper had been circulated only a few minutes before the meeting. Such discussion as developed regarding this paper indicated divergent views only with respect to paragraph 15c.

2. The Standing Group requests the Military Representatives to agree that the Standing Group Liaison Officer shall take S.G. 112/8, excepting sub-paragraph 15c of the enclosure, and sub-paragraphs 1c (3), (4) & (5) of Appendix "B", as the initial guidance needed in his discussions with the Council Deputies when they consider the detailed implementation of the agreed reorganization of NATO.

3. It is also recommended that the Military Representatives agree that, with regard to the eventual organization of the Standing Group Liaison Office and particularly to the nationality of the Assistant Liaison Officers, the Standing Group taking into account the views of the Military Representatives Committee at their 41st meeting, shall make a further study as the structure of the reorganization of the central NATO authority evolves, and make further proposals.
