MEMORANDUM FOR THE GREEK MILITARY REPRESENTATIVE

SUBJECT: Examination of the Functioning of the
COSMIC Security System in Greece

1. The Security Coordinating Committee of the Standing Group, in arranging its itinerary for the remainder of the calendar year 1952, proposes to revisit Greece and to conduct an examination of the functioning of the COSMIC security system in the Greek governmental departments, both military and civilian.

2. It is tentatively planned that this examination will take place either at the beginning of the Security Coordinating Committee's visit to Western Europe beginning the latter part of April, or at the conclusion of that visit which would be sometime between the 1st and 15th of May 1952.

3. It will be appreciated if you will advise the Standing Group of your Government's preference as to the time for the visit of the Security Coordinating Committee to Athens.
