MEMORANDUM FOR THE TURKISH MILITARY REPRESENTATIVE

SUBJECT: Call Sign Book for Ships - ACP 113

1. Collective calls for "Any or all Turkish Naval Auxiliary" and "Any or all Turkish Navy Warships" are contained in reference b, page 21-1. These listings are identical to the format of reference a except for Call Sign "TBDJ" which appears in Column 1 for the collective "Any or all Turkish Naval Warships" instead of "TBDT" which had previously been allocated by the Turkish Authorities and included in reference b with assignment to the GELIBOLU (DD).


