


STANDING GROUP AUTHORIZES THE ACTIVATION OF A HEAD-QUARTERS 6TH ATAF AT EXMIR BUT IS UNABLE TO MAKE ANY COMMITMENTS AT THIS STAGE AS TO COMPLEMENT OR INTERNATIONAL FINANCING. 2°. AS REGARD THE PROPOSED COMPLEMENT SACEUR SHOULD PROCEED TO ACTIVATE THE HQ WITH THE MINIMUM POSSIBLE NUMBER OF PERSONNEL OBTAINING THEM BY DIRECT NEGOCIATION WITH THE NATIONAL GOVERNMENTS CONCERNED IN THE USUAL WAY. A MORE DEFINITE STANDING GROUP PRONOUNCEMENT ON THE COMPLEMENTS ASPECTS MUST AWAIT STANDING GROUP CONSIDERATION OF THE FULL PICTURE OF NATO MILITARY HQ AND AGENCIES PERSONNEL REQUIREMENTS WHICH IS REFERRED TO IN SGM-934-53 AND WHICH AWAITS INTER ALIA SACEURS COMMENTS ON THE MCC REPORT AND HIS REPLY TO TOSHAP 461. 3°. AS REGARDS FINANCING, THE COUNCIL WILL MAKE ITS DECISION IN DUE COURSE IN ACCORDANCE WITH THE PRINCIPLES LAID
